- ◆ The exhibitor is hereby given the right to cancel this agreement without penalty at or any time prior to 30 days in advance of the MMBA meeting, such cancellation to be effective when written notice thereof is received by the MMBA Headquarters, Lansing, MI. **A \$75.00** administration fee will be assessed on any refunds. After the 30-day period, no refunds will be issued. All accounts must be settled within this time.
- ◆ The Exhibitor assumes the entire responsibility of liability for losses, damages, and claims of injury or damage to the Exhibitor and its representatives, displays, equipment and any property brought onto the premises of the host facility and shall indemnify, hold harmless, and release MMBA and the host facility agents, servants, and employees from any liability entirely for such losses, damages and claims.
